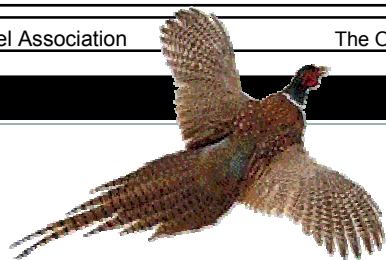

Welcome to the new MHSA board. We are fortunate this year, as is usually the case, to have a superb group of people who have stepped forward to help guide MHSA during 2009. Our second meeting of the year, following the one held at the annual banquet, will be held at the Richfield Baker's Square on 66<sup>th</sup> street. As always, it is open to all members. If you are interested in the club's plans for the coming year or have suggestions to offer board, plan to attend. A number of this year's board members started attending meetings near the end of last year. They are now members of the board and all of you will benefit from the contributions they made last year, prior to officially joining the board.

Despite a brutal workload occasioned by the changing economy, I've managed to do some training with a few club members during recent weekends, sometimes in below zero weather. Birds have been found by eager dogs, have flown, been retrieved and all have managed to stay warm. The dogs, especially, have enjoyed the runs in brisk weather. Last weekend I did a bit of scratch hunting at a local club, running my Cockers for about an hour and Zorro, my Setter, for an hour in minus five temperatures. All stayed warm and happy and due to the hard work of plowing through deep snow, I was especially warm. The long legs of Zorro and his wide ground coverage added more to the bag than the Cockers. Zorro accounted for three birds to the Cocker's combined one, or, if a Cocker produced wide flush counts, two. I'm still wedded to Spaniels for pheasants, but the birds were sitting tight, often on open south slopes under pines where it was warmest, and fewer were in the cattails where Spaniels shine at this time of year.

Trialing friends in California and elsewhere have told me they are feeling the pinch from the current economy and may be travelling less to trials this year. I assume the same is true for our club members, whether your event of choice is in the field, obedience indoors, or an agility course. Keep in mind that our club events are all local, cheaper and easier to get to, and often even more fun than distant events. Our fun trials, for example, have all the challenge of an AKC field trial with lower entry fees, lower travel fees and, assuming you come from home, no hotel/motel cost. We will be having three of them, so get every one on your calendar. They have become so popular that people came from South Dakota and eastern Wisconsin last year.

### Presidents' Letter Continued...

To wrap things up, here are a few comments on the effects on wildlife of our first true Minnesota winter in some time: In December, I started seeing the first dead long and short tail shrews. I'm not sure why I saw so many. For some reason they must have been having trouble finding the insects necessary to fuel their high metabolic rates. In other years, I have found more mice and voles dying off and not until much later in the winter. Recently, the dogs have pulled a number of moles from the snow. I suspect that the deep snow cover has caused them to come closer to the surface than in other years, but again don't know the reason, only that it is different than other years.

Also different is the early departure of a number of raccoons from wintering tree cavities. I usually see one or two who have exhausted their winter fat and had to leave early to search unsuccessfully for food in late February or early March. They come out, circle in the snow, then die to be fed on by Redtails or coyotes. This year, two left a frequent nest cavity by the lake before the end of December, dying at the base of the tree.

The deer are travelling widely. Their tracks in the snow reveal that many have started dragging their feet. It is a tough winter for the wildlife. For some, the deep snow offers shelter: the mice and voles are insulated by the deep snow, as are Grouse which burrow under it at night to stay warm and away from owls.

The coyotes, now in heat as apparent from the blood drops in the snow, are travelling widely and judging from their scats, catching not only mice, voles and rabbits, but also finding the occasional carrion deer. A Redtail has been enjoying the squirrels a trapped that were getting into a container where I keep food for my birds, as well as the occasional pigeon I place on the roof of a pigeon coup. The feathers he thoroughly plucks litter the ground. I could put him to work during hunting season if he would relinquish the birds after plucking!

Get out and enjoy the country with your dogs. There is lots to see and the occasional bird to flush.

1. Minutes of December 2, 2008 – Motion to approve the minutes – Charlie Casey, second by Ann Sunderman – Approved
2. Discussion to approving meeting minutes prior to sending for publishing in the club's newsletter. Secretary to send via email to Board members for approval prior to publication.
3. Suggestions for next years banquet were discussed. Good options were presented. Ann Sunderman will Chair the 2010 Banquet.
